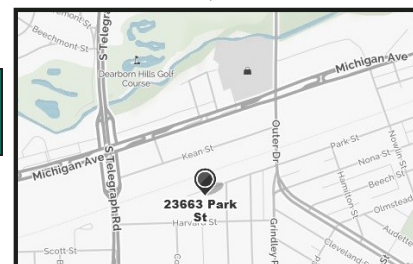

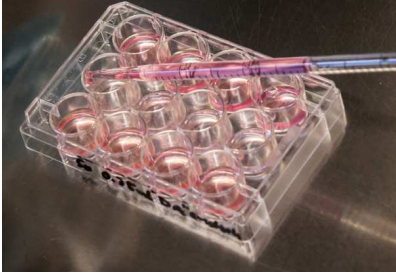

## Major embryonic stem cell biotech company going out of business

A California biotech company specializing in the use of fetal stem cells for research is going out of business.



StemCells, Inc. will cease operations, *Reuters* reports, in the wake of the company terminating a mid-stage test of its spinal cord injury therapy, and six months after it had said the therapy was showing promising results.

The Food and Drug Administration (FDA) approved StemCells, Inc.'s research using fetal brain tissue to treat macular degeneration in 2012, with the fetal brain tissue coming from miscarried or aborted children.

The biotech's press release on the FDA authorization at the time referred to its proprietary product in the trial, HuCNS-SC, as "purified human neural stem cells." However, the description of the HuCNS-SC as "fresh human fetal brain tissue," available at the time elsewhere on the StemCells, Inc. website, has since been removed.

StemCells, Inc.'s focus remained on its HuCNS-SC for research on spinal cord injury, retinal disorders and neurodegenerative diseases.

The company opted to end the spinal cord study after an in-depth review of data from the study and getting "concurrence" from the study's Interim Analysis Data Monitoring Committee, with analysts saying "a tough market environment and long clinical path ahead drove a financial/clinical failure."

"In light of the decision to terminate the Pathway Study, the company's available strategic alternatives and its current cash position, the board of directors approved a plan to wind down the company," its announcement on terminating the study and ceasing operations stated. "As part of this process, the company will evaluate opportunities to monetize its intellectual property, including data collected in its studies and trade secrets, as well as the transfer of its proprietary HuCNS-SC cells and other assets through a potential sale."

StemCells, Inc. said it will lay off its 50 employees and record a one-time charge of approximately \$1.25 million in the third quarter ending September 30. The company's stock plunged 85 percent with the announcement.

The controversial concept of fetal tissue research has received renewed attention in light of the Planned Parenthood fetal tissue trafficking scandal.

## Pro-Life advocate demolishes abortion in United Nations speech: "Every human being has a Right to Life!"

Minnesota Citizens Concerned for Life's Global Outreach program (MCCLGO) addressed a session of the United Nations Human Rights Council in Geneva. Mary Langlois, representing the organization, made the case that legalized abortion is not necessary to ensure women's health and is not required under international law.

The Human Rights Council, an inter-governmental U.N. body founded to promote and protect human rights worldwide, is holding its 32nd session this month. Langlois presented an oral statement during a meeting considering the issue of discrimination against women.



A Working Group report on the subject has called for the legalization of abortion around the globe, even condemning so-called "barriers to access" such as waiting periods prior to abortion.

"Legalized abortion is not required by the right to health. Maternal health depends on the quality of medical care, not on the legal status or availability of abortion," Langlois said. "We can save women's lives in the developing world by ensuring proper care before, during and after childbirth, including adequate nutrition, prenatal care, skilled birth attendants, emergency obstetric care, clean water and sanitation."

MCCLGO noted that there is no right to abortion under international law. On the contrary, said Langlois, various international human rights instruments—such as the Universal Declaration of Human Rights, the International Covenant on Civil and Political Rights, and the Convention on the Rights of the Child—"provide support for the equal protection of human beings at all developmental stages and in all conditions, which should include human beings *in utero*."

The International Covenant on Civil and Political Rights states, "Every human being has the inherent right to life. This right shall be protected by law. No one shall be arbitrarily deprived of his life." The Declaration of the Rights of the Child affirms that "the child...needs special safeguards and care, including appropriate legal protection, before as well as after birth."

Langlois concluded her statement by urging the Human Rights Council "to recognize that abortion is not required by international law, and to respect the sovereignty of countries to determine their own abortion policies."

## Bigot Peter Singer: Don't pay to treat disabled babies

Peter Singer is a bigot. Rather than believing in universal human equality, he would invidiously measure the capacities of human beings to determine whether they are "persons." Those with insufficient capacities, are to be deemed human "non-persons," are to be viewed of lesser moral value, and hence, potentially subject to both killing and objectification for harvesting, medical experimentation, etc.

He also supports health care rationing based on quality of life. This blatant medical discrimination would victimize babies born with severe disabilities—whose care, Singer argues, should not be paid by national health insurance schemes.

The National Council on Disability is not amused.

From its press release: On Sunday, April 16, contentious Princeton Professor Peter Singer, once again argued that it is "reasonable" for the government or private insurance companies to deny treatment to infants with disabilities. Singer's remarks were made on "Aaron Klein Investigative Radio," which is broadcast on New York's AM 970 and Philadelphia 990 AM.

In the interview, which was perhaps ironically conducted as part of a press tour Singer is currently on promoting his new book about charities, "The Most Good You Can Do: How Effective Altruism Is Changing Ideas About Living Ethically," the professor advocated the shocking claim that health care laws like the Affordable Care Act should be more overt about rationing and that we should acknowledge the necessity of "intentionally ending the lives of severely disabled infants."

"Mr. Charity" then makes an uncharitable utilitarian assertion:

Without offering any concrete measure on how quality of life could or should be determined, Singer admitted, "I don't want my health insurance premiums to be higher so that infants who can experience zero quality of life can have expensive treatments."

The NDC makes a point about Singer that is also lost to the media slavishly pushing assisted suicide/euthanasia, which also threatens the lives and bodily integrity of people with disabilities:

Increasingly, negative predictions of quality of life have little to do with the actual life experiences of people with disabilities. People with disabilities commonly report more satisfaction with their lives than others might expect.

Though it might surprise Singer and those with limited imaginations, even people with disabilities who encounter obstacles, prejudice, and discrimination, derive satisfaction and pleasure from their lives.

Singer is something of the ethicist in chief for such liberal organs as the *New York Times* and leftist columnists like Nicholas Kristof. That says a lot about liberal thinking, it seems to me.

The Left talks a good game of equality, but when it comes to people with disabilities (among other categories of human life), they don't really mean it. Indeed, when they support Peter Singer, they validate invidious quality-of-life bigotry.

### **Ruth Bader Ginsburg Promotes Abortion: “No Law Should Deny a Woman Her Right to Choose”**



Supreme Court Justice Ruth Bader Ginsburg has become a favorite figure among abortion activists because she does not shy away from pro-abortion politics.

Ginsburg gave a rare interview to the *New York Times* recently and talked about her pro-abortion position and the presidential race. She was one of the five justices who sided with abortion activists in the recent decision *Whole Woman's Health v. Hellerstedt*, which struck down Texas abortion clinic regulations.

At the end of June, the Supreme Court reversed part of the pro-life Texas law that protected women's health, saved the lives of thousands of unborn children and closed abortion clinics that could not ensure adequate health and safety protections for women. At issue in the ruling were two provisions: that abortion clinics meet the same building standards as ambulatory surgical centers and that abortionists have admitting privileges at a nearby hospital for situations of medical emergencies.

Ginsburg and four other justices ruled that these safety regulations were an “undue burden” on women's access to abortion. Justice Anthony Kennedy, a swing vote on abortion decisions, sided with the pro-abortion justices in the case.

Ginsburg described Kennedy as “the great hero of this term” because of his vote on the Texas case. She said laws should not deny a woman “her right to choose” abortion. She told the *New York Times*:

Asked if she had been pleased and surprised by Justice Kennedy's vote in the Texas case, Justice Ginsburg respond-

ed: “Of course I was pleased, but not entirely surprised. I know abortion cases are very hard for him, but he was part of the troika in *Casey*.”

Justice Breyer wrote the methodical majority opinion in the Texas case, and Justice Ginsburg added only a brief, sharp concurrence.

“I wanted to highlight the point that it was perverse to portray this as protecting women's health,” she said of the challenged requirements. “Desperate women then would be driven to unsafe abortions.”

The decision itself, she said, had a message that transcended the particular restrictions before the court.

“It says: ‘No laws that are meant to deny a woman her right to choose,’” she said.

Ginsburg also appeared to imply that Justice Antonin Scalia's death was a boon for the high court's liberal policies.

“Think what would have happened had Justice Scalia remained with us,” she said.

In a bold, political move for a U.S. Supreme Court justice, Ginsburg also openly criticized presidential candidate Donald Trump, who says he is pro-life. High court justices tend to avoid talking about politics in public because it could lead to the appearance of bias in their decisions.

Ginsburg, however, had no qualms about criticizing Trump and the power he would have as the next president to nominate justices to the Supreme Court.

“I can't imagine what this place would be—I can't imagine what the country would be—with Donald Trump as our president,” Ginsburg said. “For the country, it could be four years. For the court, it could be—I don't even want to contemplate that.”

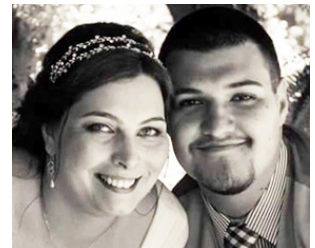

# The Truth is On Our Side

With the recent striking down by the U.S. Supreme Court of pro-life laws in Texas, the timing of the National Right to Life Convention (NRLC) in Herndon, VA, July 7-9, couldn't have been better—and, as a member of Right to Life - LIFESPAN, I couldn't have been more pleased to attend the event in person.

Does that mean the NRLC was an entirely feel-good event? To be honest, no. After all, we were there to talk about some of the most difficult issues of our time: abortion, the growing trend of euthanasia and the health care rationing inherent in “Obamacare”—to name just a few.

These are hardly happy topics. But they're topics we need to address—courageously, unabashedly, truthfully—if we're to be worthy witnesses to life. In fact, it is in that commitment to truth that we find hope of turning things around in favor of a culture of life.

So how do we share that hope, especially with those hurting from the aftermath of abortion? First, in this particular area, we need to share the truth about how abortion harms women. Denying the consequences doesn't diminish the harm, it only forces women to suppress their own trauma. By acknowledging a woman's suffering, we can then offer her compassion and information on how and where she can find healing.

Unfortunately, one thing we hear very little about in the “mainstream” culture is that abortion does indeed harm women. But if abortion is no big deal, like the abortion industry would like to have us believe, then why was one of the most common themes at the NRLC centered on the emotional and physical consequences of abortion? Why is there such a contrast between truth and society's willingness to admit it?

*HUSH*, a documentary shown at the NRLC ([www.hushfilm.com](http://www.hushfilm.com)) does an incredible job of exposing this. Not only does it detail the alarming link between abortion and breast cancer, premature birth and other risks, it reveals the astonishing silence of the abortion industry and others regarding these risks.

As *HUSH* details, it took only seven studies establishing the link between tobacco and cancer to get the federal government to mandate warnings on all tobacco products. Yet despite over 120 studies concluding that abortion greatly increases breast cancer risks, the National Cancer Institute and other prominent organizations refuse to even acknowledge these findings, let alone push for government mandates to warn women of the risks.

In other words, politics, not science, is steering the issue right now. Denial like this makes it increasingly appalling to hear abortion advocates refer to any of this as women's healthcare, when clearly women's health and well-being are not the primary concerns of this billion

dollar industry. Then again, can we genuinely expect those who don't value pre-born life to value any life?

This devaluing of human life is especially evident today toward the elderly and otherwise medically challenged. Addressing this, speakers at the NRLC gave extraordinary testimonies about the need to be stalwart advocates for our and our loved ones' healthcare. From one mother's experience with a hospital encouraging her to stop treatment for her son's Trisomy 18 condition, to a brother dealing with a hospital's stonewalling to administer food and water to his elderly brother, it was chillingly clear that just because someone is in the healthcare field, it isn't a guarantee he or she will do everything possible to save a life.

With government policy like Obamacare increasingly demanding cuts in health spending, coupled with our throwaway culture of death, we may find ourselves at the mercy of faceless bureaucrats who will decide which of our lives are worthy of the cost to preserve them.

Even worse, we may find ourselves at the mercy of health professionals under pressure to keep costs down, the same professionals who may also share in today's rising attitude that healthcare should be less about restoring health and preserving life, and more about eliminating suffering at all costs through things like euthanasia. That's why, by the way, it's critical to have pro-life Will to Live documents, and even carry them with us in our wallets (e.g., in the form of a mini-card you can attach to your insurance card). Even then, you or your loved ones better keep an eye on the medical facility treating you to make sure they're adhering to your wishes.

Despite the hard issues addressed at NRLC, the prevailing attitude was assuredly one of hope. As mentioned before, fundamental to that hope is that we have truth on our side: simply put, the value of every human life is not up for debate. But how do we present the truth of the pro-life movement in the most effective way to change hearts? That is the million dollar question indeed.

Of course it starts with being witnesses ourselves to the joy and value of life. But one other thing we must continue doing is acknowledge that while facts are necessary to share, simply bombarding others with nothing but statistics, judgments and atrocities may just further harden the hearts we want to change. To the best of our ability, we need to share the truth we know, but must share it with calmness, compassion and love to a society desperately in need of these things.

The bottom line is, whatever your job, whatever your vocation, whatever your place in life, you have it in you to change hearts because you have the key ingredient already in you: the truth that every life matters, from conception to natural death. It is in sharing that truth that we can ultimately make ours a Culture of Life, one heart at a time!

# You Won't Believe How Much Psychological Damage Abortion Causes Men

**A**bortion often does tremendous physiological damage on the fathers, as well as the mothers. Speakers recently discussed the important, but often forgotten, need for counseling post-abortive fathers during a Project Rachel orientation day at the Philadelphia Archdiocesan Pastoral Center, *Catholic Philly* reports.

Guest speaker Victoria Thorn, founder of the National Office for Post Abortion Reconciliation and Healing and Project Rachel, explained how abortion affects many individuals in addition to the mother. Other family members and even friends experience the impact of a woman's abortion decision. Research has found that abortion often affects the aborted babies' siblings, too.

"Few people ever address the psychological impact. People are hurting from this because they have all kinds of emotions around this. Some men are walking around being so angry because a woman had an abortion and didn't tell them," Thorn said.

She explained that some fathers don't fully realize the effect the abortion has had on them.

"Since men are not as expressive, they do not know where to channel that anger. Sometimes they take that anger out on every woman who comes into their life. Everyone is wondering why he is so angry, and it is from a pain that he just stuffed inside."

The event's moderator was Steve Bozza, director of the archdiocesan Office for Life and Family, according to the news outlet. He addressed the common misconceptions surrounding abortion: "Many do not realize that many lives can be ruined or shattered by an abortion. Whenever a child is lost there is a need for social services and resources. Unlike a miscarriage or stillbirth where there is no choice, this is something that is a choice. Many only come to grips with that after the fact."

"Sometimes the men are angry and you touched on every topic, and the rage is still there," Bozza said. "Now, this is one of the things I will bring up when listing things that could have happened. I found it helpful to discuss something even we as counselors really do not discuss. I am sure as counselors we have had clients who are ashamed to bring it up."

The program had several other key speakers, including Kathryn Dobbs, Mary McGinley and Kevin Burke, according to the *Catholic Philly*. Burke is a director of Rachel's Vineyard, which reaches out to people adversely affected by an abortion and provides hope and healing.

In a 2007 interview, Burke said men are involved in 95 percent of all abortion decisions and often are "profoundly impacted" by the abortion of their child. He said the program has seen a steady increase in the number of men seeking healing after an experience with abortion.

"Similar to women, when men experience deep healing of post abortion pain, they are freed from the shame and guilt that feeds silence and isolation," he said. "There is a willingness to share their experience with others because they finally recognize that their feelings are normal, they are not alone."

In the midst of important conversation regarding abortion and the mothers, the negative effect it has on fathers is often forgotten. Abortion isn't just something between a woman and her doctor. It impacts countless individuals. It is excellent that these issues are being discussed in places such as the Philadelphia Archdiocesan Pastoral Center, so that church leaders can more effectively counsel people experiencing post-traumatic repercussions.

## *Man Gets Married 16 Months After Nearly Dying and Having All of His Limbs Amputated*

**A**n Illinois couple's love story almost came to a tragic end 16 months ago when Ethan Menges contracted a deadly illness. Menges lost all four of his limbs and almost his life to the virus, but his fiancée Jordan Mathieu stayed by his side and devoted herself to helping him recover. *ABC 13* reports the couple's rocky journey led to a joyous occasion this May when the two walked down the aisle together and were married in Roscoe, Illinois.

"It's weird because for the majority of our relationship, this past year and a half, two years, was in a hospital setting, not the typical things you do going out on dates, going to movies, hanging out with families, it was bedside," Menges told reporters.

Menges said he even proposed to Mathieu in his rehab room. He said his bride's devotion during his near-death experience really touched him.

"That means more than the world to me, because I know she'll always be there, she's been there through that, I'd have to really screw something up," he said.

The young man collapsed at a sports game last January after contracting a flu-like virus; the illness developed into walking pneumonia and spread across his body, infecting his lungs and bloodstream, according to the report. The illness affected his circulation and forced doctors to amputate all four of his limbs. At one point, doctors even told Menges' family to start planning his funeral, his sister Brittney said. Though hope was slim, Menges pulled through with encouragement from his family and his soon-to-be bride. Menges went through months of intensive therapy and now has prosthetic limbs. They allowed him to walk down the aisle with Jordan on May 14. Jordan could not put a ring around her husband's finger, so she placed a necklace with the ring around his neck instead, the report states.

The couple's beautiful story of devotion and perseverance is a stark contrast to the message of a new summer romance film, "Me Before You." The film romanticizes assisted suicide through the story of a rich young man who becomes a quadriplegic and gives up on life. Despite his caregiver-turned-lover's attempts to show that his life has meaning, he chooses to commit suicide anyway. She even caves into his decision to kill himself. The film has disability rights advocates and pro-lifers upset because of its pro-euthanasia tones.

British actress Liz Carr told *The Guardian*: "We have so few opportunities in the media to explore disability. But there is a disproportionate number of stories which relate to the 'problem' of disability being solved by death. Television and film seem to love those individuals who want to die. They're less keen to cover the rest of us who might want to live but are struggling to get the health and social care resources to do so."

Unlike "Me Before You," Ethan and Jordan Menges' real-life love story has the type of happy ending that should be celebrated in the media. The couple did not let Ethan's disabilities or his illness stand in the way of their joy. Their story is an example of how true love never gives up hope and always perseveres.
